Dissolution of membership will not incur a charge.

The Society reserves the right to introduce or vary administrative fees where usage of this facility is excessive or unreasonable, in accordance with the authority granted under Clause 8.8 of the Society Byelaws.

Where a charge applies, the Society will confirm the applicable fee and issue an invoice prior to processing.
